He did. And then he immediately went in up to his neck.


"Timmy!" I yelled before forcing myself to speak in a calmer voice. "Please...be careful, will vou?"

In case you are wondering what happened to the trees in the garden area, here's the scoop. The **Hibiscus plant** is prone to attract every disease and insect possible and this held true for ours. Last year they were covered with white fly and this year they attracted some type of aphid. I tried spraying them with an insecticide but did not have any luck, so we cut them down to save the remainder of the plants in the garden from being infected.

Because of the Long Beach water restrictions, which only allows for watering after 4:00 p.m. three times a week, it is becoming difficult to ensure that the potted plants have sufficient water. I am in the process of downsizing our potted plant collection so for the time being we are not accepting additional plants in the garden.
